The Panchayats (Extension to Scheduled Areas) Act (PESA), 1996 was a landmark legislation aimed at promoting decentralised and participatory governance in India's tribal regions. Its significance becomes even more pronounced when analyzed through the lens of gender empowerment and economic self-reliance. In the Bastar district of Chhattisgarh, where tribal women are deeply embedded in forest economies and community life, the implementation of PESA has the potential to transform socio-economic realities. The aim of this study is to achieve following objectives: To find out the tribal women in Bastar regions of Chhattisgarh face numerous challenges is Domestic Violence, violence under the guise of naxalism, lack of inclusion in local governance, displacement and deforestation, loss of forests etc. The specific needs and priorities of tribal women in Bastar of Chhattisgarh may vary. However, the research also highlights the challenges faced gender equality within the context of PESA implementation, such as socio-cultural norms, limited resources and lack of awareness.

This paper examines the intersection of tribal governance, women's empowerment and the economic ideals of Sardar Vallabhbhai Patel whose vision for a united and self-reliant India encompassed strong local governance. It argues that realising Patel's vision requires not only political integration but also the economic empowerment of marginalized communities especially women through democratic decentralization. This study evaluates the implementation of PESA in Bastar by drawing on empirical insights, policy frameworks, and the evolving role of tribal women. It concludes that a gender-inclusive application of PESA is crucial to achieving both local self-rule and national self-reliance.

The PESA Act enacted in 1996 aims to enhance democratic governance in Scheduled Areas of India particularly for tribal populations. The PESA Act (Panchayat Extension to scheduled Areas Act) introduced to empower tribal communities has a significant impact on the governance and social structure of the tribal areas in Chhattisgarh particularly in the Bastar district. This Act aims to decentralize governance and extend the provisions of the panchayats to the Scheduled Areas thereby giving more power to local tribal communities. Gender equality in this context is not only a matter of rights but also essential for sustainable development (Bhatia, 2020). The 73<sup>rd</sup> Amendment to the Indian Constitution made provisions for the reservation of one-third seats for women ensuring their empowerment in the rural power structure.

Sardar Vallabhbhai Patel, the Iron Man of India envisioned a united yet decentralized nation, where grassroots governance and inclusive development would pave the way for self-reliance. His economic thought emphasized local self-governance, rural empowerment and equitable participation in nation-building. Today, this vision finds resonance in the PESA Act particularly in tribal regions like Bastar where governance, identity and resource control remain deeply interwoven. The Bastar district of Chhattisgarh rich in mineral resources and tribal culture also suffers from poverty, marginalization, and underdevelopment. The implementation of PESA in this region has the potential to change this narrative especially by focusing on the economic empowerment of tribal women the backbone of rural and forest-based economies.

This paper emphasizes a synergistic approach to implementing the PESA Act recognizing the interplay between policy frameworks and community dynamics. This study has been carried out to examine their political experiences, motivations and empowerment. Empowerment for tribal women is defined as a process of gaining self-awareness, consciousness, and confidence. It is about creating an environment where these women can make choices and decisions that lead to social transformation. This empowerment is not just about individual growth but also about collective progress within the community (Panigrahi, 2017). One of the key outcomes of the PESA Act's implementation has been the transformation in gender equality with a marked improvement in the empowerment of tribal women.

The PESA Act of 1996 extends the provisions of the 73<sup>rd</sup> Constitutional Amendment to Scheduled Areas allowing for self-rule by Gram Sabhas (village assemblies) in tribal regions. PESA recognizes traditional tribal governance systems and grants Gram Sabhas control over natural resources, minor forest produce, land acquisition, and cultural preservation (Ministry of Panchayati Raj, 2006). In districts like Bastar, where Scheduled Tribes (STs) constitute over 60% of the population (Census of India, 2011) this law is a potential tool for self-governance. However, PESA's implementation has faced numerous challenges ranging from bureaucratic inertia and lack of political will to the persistent conflict between traditional practices and modern state structures. Despite these issues, PESA remains a potent legal tool for participatory governance particularly for empowering tribal women through institutional mechanisms.

A review of existing literature reveals gaps in understanding the dynamics of gender equality within the PESA framework. The studies on PESA implementation and tribal women's empowerment in Chhattisgarh have highlighted the challenges faced by tribal women in accessing education, healthcare and economic opportunities. These challenges are exacerbated by gender-based discrimination, social norms and limited access to resources. While PESA provides a legal framework for decentralized governance its effective

implementation depends on various factors including political will, community engagement and resource allocation. There are previous research has also emphasized the importance of integrating gender equality initiatives with PESA implementation to ensure that women's voices are heard and their needs are addressed. The paper stated have shown that when women are involved in decision-making processes they are more likely to prioritize issues that affect their lives. In this research indicates that while women's representation has increased their actual influence in decision-making remains limited (Kumar & Singh, 2022). Previous studies have emphasized the role of socio-cultural norms in constraining women's empowerment pointing to the need for targeted interventions (Jain, 2023).

In the context of Bastar district in Chhattisgarh is one of the most geographically diverse and culturally rich regions in India. It is home to a large and diverse population of Tribal people, including the Gond, Maria, and Bhatra tribes. However, despite its rich cultural heritage Bastar district faces significant challenges including: Poverty and underdevelopment are widespread in the district, with high levels of illiteracy, malnutrition, and lack of access to basic amenities. Tribal communities in Bastar have faced significant land alienation and displacement due to mining, industrial development, and other developmental projects. The region has witnessed a long history of conflict and violence, including the Naxalite insurgency. Despite significant progress in recent years, gender inequality remains a major challenge in Bastar with women facing discrimination in various spheres of life.

### **3. The PESA Act and the Quest for Gender Equality among Tribal Communities: A Synergistic Approach**

The Panchayats (Extension to Scheduled Areas) Act (PESA) enacted in 1996 is a landmark legislation aimed at empowering tribal communities in India particularly in areas designated as Scheduled Areas. Its implications for gender equality are particularly significant as it seeks to enhance women's participation in local governance and decision-making processes. The PESA Act provides an important opportunity to advance gender equality in Tribal communities. By empowering Gram Sabhas, the Act can create a space for women to participate more actively in decision-making processes. Women in local governance positions often advocate for issues that affect their communities, such as healthcare, education, and resource management. Their involvement leads to more inclusive and representative decision-making processes addressing the specific needs of tribal women. Despite these advancements women still face socio-cultural barriers that limit their effective participation. Deep-rooted gender biases and traditional roles often hinder their influence, necessitating targeted interventions to address these challenges.

For the PESA Act to fully realize its potential a synergistic approach that combines legal empowerment with community mobilization and capacity-building initiatives is essential. Training programs and awareness campaigns can help overcome cultural barriers and enhance women's leadership skills. The continued success

of the PESA Act in empowering tribal women will require sustained efforts from policymakers, community leaders, and NGOs. Future strategies must focus on creating supportive environments that foster gender equality and empower women to take on leadership roles. In this context, while the PESA Act has made significant strides in empowering tribal women in Chhattisgarh, ongoing efforts are needed to address cultural barriers and enhance the effectiveness of women in governance.

## 5. Gender and Economic Empowerment through PESA

Tribal women in Bastar are not only key contributors to household sustenance but also custodians of traditional ecological knowledge. They collect, process, and trade minor forest produce (MFP) like tendu leaves, mahua flowers, and tamarind, yet they rarely control the terms of this economic exchange (Sundar, 2009). PESA empowers Gram Sabhas to:

- Safeguard community rights over land and forest resources.
- Ensure women's participation in local governance.
- Promote economic cooperatives and self-help groups led by women.
- Enable decentralized resource management with a focus on equity.
- Facilitate inclusive economic decision-making (Roy, 2005).

Empowerment through PESA is not merely administrative; it is transformative shifting the agency to tribal women and making them active participants in shaping their own development pathways. In practice, however, women are often sidelined from Gram Sabha processes due to entrenched patriarchy and lack of institutional facilitation. Correcting this imbalance is critical for equitable development.

## 6. Sardar Patel's Vision and Decentralized Self-Reliance

Sardar Patel strongly believed in empowering rural institutions to foster national self-reliance. In a speech to village leaders, he remarked: *"India's future lies in its villages. Empower the village and you empower the nation"* (Patel, 1948 & Gopal, 1974). This vision closely aligns with what PESA aspires to achieve. By supporting decentralized governance in Patel's thinking was not only about governance but about building local economic capacities. When tribal women in Bastar gain financial autonomy through rights over forest produce and representation in decision-making bodies, it constitutes a tangible realization of Patel's ideals. In today's context, implementing PESA effectively in Bastar is a realization of this vision. When tribal women gain economic independence and decision-making power they not only transform their communities but also contribute to national development goals.

## 7. Transforming Bastar: A Roadmap for Empowerment

Transforming Bastar district requires a multi-pronged approach that addresses the social, economic, and political challenges faced by its people. This approach should be guided by the principles of the PESA Act and gender equality. Key elements of this roadmap include: Strengthening the capacity of Gram Sabhas to effectively exercise their powers and functions under the PESA Act. This includes providing training to Gram

Sabha members, improving access to information and enhancing their decision-making capabilities. This includes providing women with leadership training, mentorship opportunities and support networks. Implementing effective measures to prevent and address gender-based violence in Tribal communities. This includes strengthening law enforcement and judicial systems, providing support services to survivors of violence and raising awareness about gender-based violence. It's Promoting the economic empowerment of women through initiatives such as microfinance, skill development programs, and access to markets. Improving access to quality education and healthcare for women and girls in tribal communities in Scheduled Areas. Protecting and conserving natural resources such as forests and water bodies which are crucial for the livelihoods of Tribal communities. Addressing the issue of displacement of tribal communities due to development projects by ensuring that their rights are protected and that they are adequately compensated for any losses. Promoting peace and reconciliation in the region through dialogue, conflict resolution mechanisms, and community-based initiatives. The successful implementation of the PESA Act and the empowerment of Tribal women in Bastar require the active participation of various stakeholders:

- *Government:* The government has a crucial role to play in creating an enabling environment for the implementation of the PESA Act. This includes providing adequate resources, strengthening administrative structures, and ensuring that government officials are sensitized to the needs and concerns of Tribal communities.
- *Civil society organizations:* Civil society organizations can play a vital role in supporting Gram Sabhas, raising awareness about the PESA Act, and advocating for the rights of Tribal women.
- *Tribal organizations:* Tribal organizations can play a crucial role in representing the interests of Tribal communities and advocating for their rights.
- *Academic institutions:* Academic institutions can contribute to the discourse on Tribal development by conducting research, providing training, and disseminating knowledge.
- *Media:* The media can play a crucial role in raising awareness about the PESA Act and the challenges faced by Tribal communities.

## 8. Methodological Framework

This study employs a mixed-methods approach to provide a comprehensive understanding the impact of the PESA Act on tribal women's empowerment. Qualitative data were collected through interviews with tribal women leaders and focus group discussions within various Gram Panchayats. Quantitative data were obtained via surveys assessing the level of women's participation in decision-making processes and their perceptions of empowerment under PESA. The sample included 150 respondents from bastar districts of Chhattisgarh ensuring a diverse representation of tribal communities. In-depth interviews were conducted with 20 tribal women leaders and focus groups involving 30 women across different Gram Panchayats. These discussions aimed to gather insights on their experiences, challenges, and perceptions of empowerment under the PESA framework. A survey was administered to 150 respondents capturing data on women's participation in



governance, decision-making roles, and perceived changes in their socio-economic status. Statistical analysis was performed to identify correlations between participation levels and empowerment indicators.

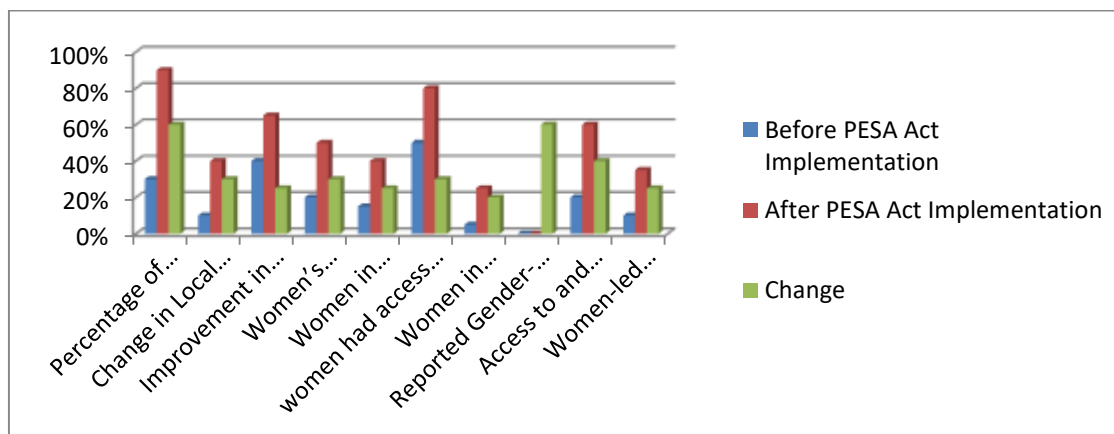

Despite its promise, PESA remains under-implemented. Key challenges include:

- Lack of awareness among tribal communities about their rights.
- Weak institutional support and limited devolution of power.
- Gender insensitivity in Gram Sabha functioning.
- Encroachments by commercial and state interests on tribal land and resources.
- To overcome these barriers, a multi-pronged strategy is essential:
- Strengthening community education and legal awareness.
- Institutionalizing women's participation in local governance.
- Promoting women-led cooperatives and value-added forest enterprises.
- Ensuring policy coherence between PESA and schemes like NRLM, MGNREGA, and Forest Rights Act.

## 11. Policy Recommendations

To operationalize Patel's vision through PESA in Bastar, the following steps are recommended:

- Strengthen legal literacy programs for tribal women to understand and claim their rights under PESA.
- Institutionalize women's leadership in Gram Sabhas through quotas, capacity-building, and peer mentoring.
- Link PESA with economic programs like the National Rural Livelihood Mission (NRLM) to support women-led enterprises.
- Ensure fair market access for MFPs with transparent procurement policies under the Minimum Support Price scheme.

## 12. Implications and Future Directions

The implications of this research extend beyond Chhattisgarh, offering valuable insights for other regions with significant tribal populations. It emphasizes the necessity of addressing socio-cultural barriers while enhancing legal frameworks. Strengthening networks among women leaders can create a collective voice for advocacy and change. The study emphasizes the importance of political will, community engagement, and resource allocation in ensuring the effective implementation of PESA and promoting gender equality.

Future research should explore longitudinal impacts of the PESA Act on women's empowerment and identify best practices from successful implementations in other regions.
